## 1. CITIZEN'S COMMENT:

No person shall be permitted to speak from a location other than the public podium. This section of the agenda is reserved for citizens wishing to address the City Council regarding a City related issue. In order to ensure adequate public notice, Idaho Law provides that any item requiring action from the Council must be placed on the agenda for an upcoming Council meeting, unless there are emergency circumstances. Comments related to future public hearing should be held for that public hearing. Persons wishing to speak will have 3 minutes. Comments regarding performance by city employees are inappropriate at this time and should be directed to the Mayor, either by subsequent appointment or after tonight's meeting if time permitting. The City Council does not take any action or make any decisions during public comment.

2. PUBLIC HEARINGS RULES - Items listed as public hearings allow citizen comment on the subject matter before the Council. Residents or visitors wishing to comment upon the item before the Council should follow the procedural steps. In order to testify, individuals must sign up in advance, providing sufficient information to allow the Clerk to properly record their testimony in the official record of the City Council. Hearing procedures call for presentation by the applicant, submission of information from City staff, and is followed by public testimony. The rules for testifying include the following: applicant will have 15 minutes to present their project; testimony by the public will be limited to 3 minutes per person.

**A. DISCUSSION** – **ACTION** - **Public Hearing- Annual Appropriation Budget-** Proposed 2024-2025 Annual Appropriation budget in the amounts of, General Fund \$496,650.60, Street Fund \$559,198.00, Library Fund \$102,339.40, Park Fund \$25,869.00, Waterworks Fund \$9,468,311.75 and Sewer Fund \$528,574.83 for a total fund appropriation of \$11,180,943.58. For the Fiscal Year beginning October 1, 2024 and ending September 30, 2025. *Council action per adoption of Ordinance 1100*.

**ORDINANCE NO. 1100 -** AN ORDINANCE ENTITLED THE ANNUAL APPROPRIATION: ORDINANCE FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2024, APPROPRIATING THE SUM OF \$11,180,943.58 TO DEFRAY THE EXPENSES AND LIABILITIES OF THE CITY OF HAGERMAN AND SAID FISCAL YEAR AUTHORIZING A LEVY OF SUFFICIENT TAX UPON THE TAXABLE PROPERTY AND SPECIFYING THE OBJECTS AND PRUPOSE FOR WHICH SAID APPROPRIATION IS MADE.
