State Street, Hagerman ID, 83334, to consider the requests from the State of Idaho, Department of Parks and Recreation, and James Herbert and Sheryl Ann Herbert for annexation/rezone applications, in-conjunction upon annexation, a comprehensive plan map and zoning map amendment.
